4. FIRST AID MEASURES

Eye Contact	Rinse eyes with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If discomfort or irritation persists contact a physician.
Skin Contact	Wash with soap and water. If injury occurs, or if discomfort or irritation persists contact a physician.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

Use extinguishing media suitable to local circumstances and the surrounding environment. Options in this case include water, CO₂, ABC Dry Chemical extinguisher, or foam. Avoid stirring up dust extinguisher stream.

Specific hazards arising from the chemical

Thermal decomposition can lead to release of irritating and toxic gases and vapors. In the event of fire, do not breathe fumes.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment, and emergency procedures

Personal Precautions	Avoid breathing dust. Use dust mask and gloves as needed or other reasonable personal protective equipment as required to prevent contact with eyes or skin. Remove ignition sources prior to clean-up.
Environmental precautions	Prevent entry into waterways, sewers, basements or confined areas. Do not flush into surface water or sanitary sewer system. See Section 12 for additional ecological information.
Methods for containment	Prevent further leakage or spillage, if safe to do so.
Methods for clean-up	Use dust mask and/or reasonable personal protective equipment as required to avoid breathing dusts. Moisten or cover powder spill with plastic sheet or tarp to minimize spreading. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust.
